Home health and hospice scrutiny continues at a high level. Providers are subjected to a myriad of audits – TPE, RAC, MAC, UPIC and more. Providers need to be prepared to respond to audits and the results of those audits. Provider's need to be prepared to respond to ADRs to ensure claims are not denied merely for lack of a response. More importantly, providers need to be prepared to appeal demands from Auditors. This is crucial, as the provider's response to the first and second levels can significantly impact litigation in front of the ALJ. This session will review the audit and appeals process. We will then address processes and considerations for responding to recoupment demands, including the use of consultants, when to involve counsel, and addressing extrapolations. We will also review key compliance efforts designed to identify and prevent issues prior to an audit.

The CAHPS (the Consumer Assessment of Healthcare Providers and Systems) survey and HOPE (Hospice Outcomes and Patient Evaluation) tool are now an integral part of hospice quality assessment. Their focus on common end-of-life symptoms including pain, nausea, dyspnea, anxiety/agitation, bowel function, and sadness can alert the hospice team to areas for assessment and opportunities for optimal symptom management. This presentation focuses on pharmacologic and nonpharmacologic strategies to evaluate, treat, and monitor these symptoms and will discuss ways to effectively communicate with patients and caregivers to maximize both patient comfort and the CAHPS and HOPE assessments.

Symptom management is a standard right of hospice patients. Hospices are tasked with developing individualized plans, including managing troublesome symptoms, considering each patient's unique needs and preferences. The Centers for Medicare & Medicaid Services (CMS) highlighted adequate symptom management as an area of quality improvement for hospice agencies and developed the Hospice Outcomes and Patient Evaluation (HOPE) tool as part of the Hospice Quality Reporting Program (HQRP). Appropriate symptom assessment visits, treatment plans, and 24/7 access to the hospice team enable effective symptom management. Considering the importance of timely symptom management to decrease suffering, for many hospice agencies, it's common practice to introduce a small quantity of medications for the management of new symptom onset. This session will highlight the potential benefits, harms, and best practices associated with planning for aggressive symptom management at end-of-life.
